23 Cal Poly Pomona defeats NAIA power Westmont, 5-2

POMONA — Cal Poly Pomona's men's tennis team outlasted NAIA power Westmont in first-round action Friday, 5-4, in the 2004 California Invitational at the Kellogg Tennis Complex, while UC Davis edged Hawaii Hilo, 5-4, to highlight Day 1 of the tourney.

In earlier action on Friday, Azusa Pacific, the No. 1-ranked NAIA team in the country, defeated Sonoma State, 9-0 and Abilene Christian, ranked 25th in the NCAA Division II, defeated Western New Mexico, 9-0.

The four winners will meet up on Saturday, while the four losing teams will also meet on Saturday. The final day of the three-day tourney is Sunday.
