**I. Pledge/Donation Agreement**

This Pledge Agreement is entered into by and between the undersigned (“Donor”) and California State Polytechnic University, Pomona through its official gift-receiving entity, the Cal Poly Pomona Foundation (Fdn.).

**WHEREAS**, the Fdn. accepts pledges, gifts and payments to benefit California State Polytechnic University, Pomona (“University”); and

It is acknowledged that any gift or payment of/on a pledge is received as an irrevocable gift and neither the University nor Fdn. is able to return any funds after they have been received.
