

# Aggies, Cougars Reach Tourney Final

*UC Davis, Azusa Pacific win at California Invitational*

**POMONA** — Cal Poly Pomona's men's tennis team fell to regional power UC Davis, 7-2, Saturday morning in Day 2 of the 2004 California Invitational at the Kellogg Tennis Complex. UC Davis advances to meet Azusa Pacific, the No. 1-ranked NAIA team in the country, in the championship match on Sunday. The Cougars beat Abilene Christian, 7-2.

Cal Poly Pomona's David Nguyen (Sr., Los Angeles, Beverly Hills HS) continued his impressive play, winning at No. 1 singles over UC Davis' Mike Chin, 6-4, 2-6, 10-7. Nguyen also teamed up with Guido Weidenfeld for a win at No. 1 doubles, 8-2.

Other than that, though, it was all Aggies as UC Davis got singles victories from Jayce Fitch, Robert Wong, Bastian Bartels, Ross Barasch and Casey McMakin.

Azusa Pacific, meanwhile, won all three doubles contests and four of the six singles matches with Abilene Christian.

Sonoma State defeated Western New Mexico, 7-2 and Hawaii Hilo edged Westmont, 5-4.

The three-day tourney will conclude Sunday at Cal Poly Pomona.
